This Supplemental Agreement is entered into pursuant to the provision of the basic contract.

Description of Modification: Renewal of Agency Contract Agreement (5th year of 5 successive one-year renewal options) between the Virginia Community College System (VCCS) and SHI International Corp for renewal of the Microsoft Campus Software Licenses Agreement (CLA) for VCCS and the twenty-three (23) community colleges.

Additional Microsoft products may be purchased including but not limited to:

- 8) Enterprise Client Access License-ECAL, 9) Forefront Security Suite of products, 10) Microsoft Server Software as Ad Hoc additions per institutional requirements, and 11) Microsoft Online Services.
